

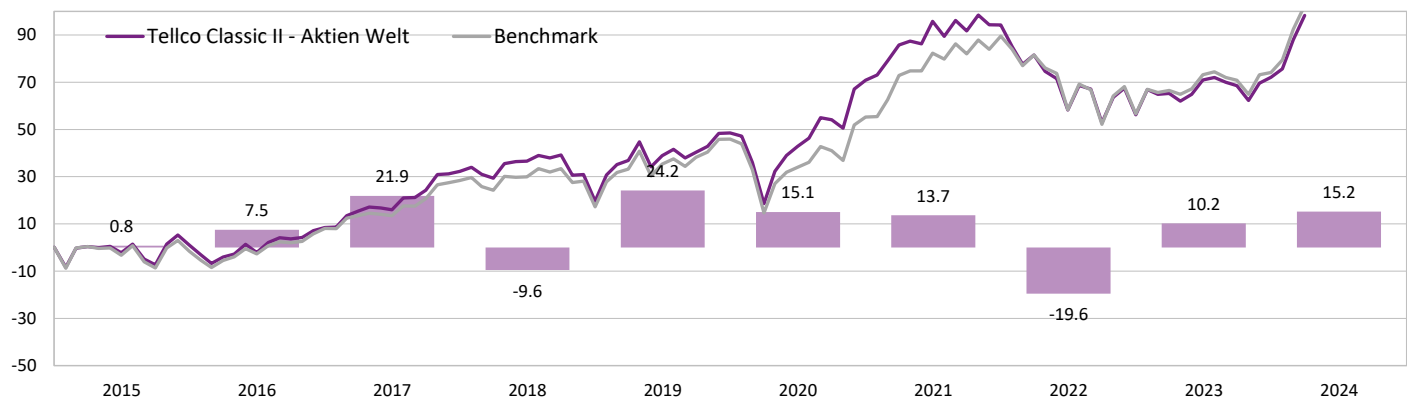

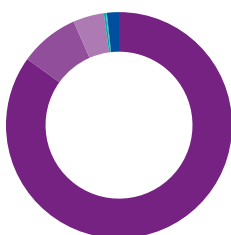

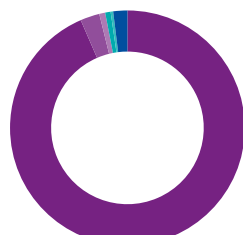

Country allocation in %



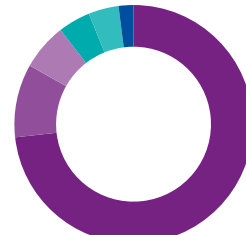
