

The currency risk is largely hedged in CHF. The underlying of these bonds is linked to the inflation index. As a result, inflation-linked bonds offer protection against inflation. The strategy is an ideal complement to an existing global bond portfolio. By means of its own active investment approach, investments are made in inflation-linked government bonds.

Sustainability policy (ESG): Companies/issuers with sustainable value creation are analysed under a) an exclusion approach (exclusion list SVVK-ASIR, companies with >10% revenue from coal production) and b) a positive positive screening approach (MSCI ESG minimum rating BBB). In total at least 80% of the invested companies/issuers must qualify as companies/issuers both sustainability approaches as companies/issuers with sustainable value creation. 


