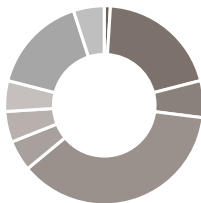
Description

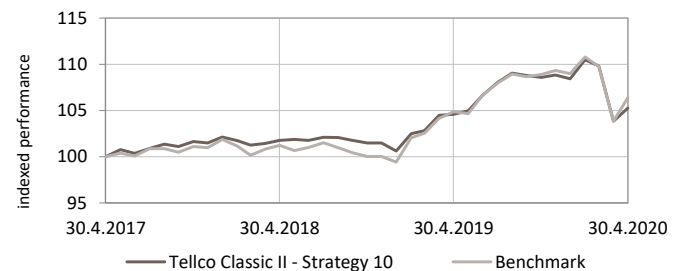
